("HT Inc." or "the Company") hereby notifies on the acquisition of Company shares by Members of the Management Board of HT Inc. Within the Company's Share Award Plan (PDD) for the managers, on 11 May 2023 HT Inc. transferred 4,380 Company's shares outside the regulated market of Zagreb Stock Exchange (ZSE) to Members of the Management Board, as follows:
